

## **Southern Home Services Giveaway Terms & Conditions**

**No purchase necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited or restricted by law.**

1.     **Introduction.** By participating in Southern Home Services' Online Giveaway (the “Contest”), participants agree to abide by these Terms & Conditions, including all eligibility requirements, and understand that the results of the Contest are final in all respects. By participating in the Contest, entrants represent that they have reviewed, accepted and agreed to be bound by these Terms & Conditions, and accept the decisions of Southern Home Services (the “Sponsor”) as final and binding in all respects. Winning a prize is contingent upon entrant fulfilling all requirements set forth in these Terms & Conditions.

To be eligible to win, the participant must reside in a home equipped with a forced air HVAC system, as the prize equipment is only compatible with this type of system. Verification of system type may be required prior to prize installation. Employees, officers, and directors of the Sponsor, its parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, and their immediate family members (defined as parents, children, siblings, or spouses) or individuals living in the same household (whether related or not) are not eligible to enter. considered eligible. Entries submitted before or after the Contest Period, or through any other method, will be disqualified. Limit one entry per household. Proof of submitting an entry does not constitute proof of receipt by the Sponsor.
